Code of conduct

In the context that the Consortium's goal is to further the realization of children's participation and citizenship rights through the strengthening and extension of children's participation.

And recognizing that as adult institutions publicly committing themselves to uphold and further children's rights they have a particular ethical and moral responsibility:

Members of the Consortium's committee themselves to a code of conduct in which they will collectively and individually:

- Strive to ensure that all their actions and decisions to the best interest of children are always given full consideration.
- Respect children's opinions and give them space and opportunities to voice them.
- Ensure that children have access to all the information they need in relation to the activities of the Consortium.
- Not in any way misuse their privileged access to the lives of the children through engaging in tokenistic action or actions of organizational or personal gain or self aggrandizement
- Mobilize the maximum available resources to further the cause of children's rights
- Aspire to the practice standards implicit in the principles and provisions of the convention.
- Work to assist others to realize the goals of the convention

By making commitments to the above, members of the Consortium recognize that they constitute both an example to other adult institutions and a role model to the child clubs them self.
